2. PUBLIC COMMENT (00:03:52):

A. Don Kandalec of Dunne Road intended to speak on a topic, but experienced audio issues. Comments would be received during the Parks report.

3. MAYOR'S REPORT (00:06:43)

- A. City park facilities remained open, with City Hall opening for appointments only. During appointments, all visitors and staff in the building are required to wear masks. Plexiglass shield for the office counter were also installed.
- B. Reduced revenue from sales and gasoline taxes were anticipated. Tax revenue estimates for the 2020-2021 fiscal year were delayed, but anticipated to be deceived by the end of July.
- C. **RESOLUTION 05-2020**

4. ATTORNEY'S REPORT (00:13:33):

A. The status of virtual meetings under the governor's executive order was not available. Attorney Buhr discussed options for holding a physical quorum during meetings with other members attending virtually.

5. **COMMISSIONER REPORTS**

- A. BUILDING AND ZONING COMMISSIONER MARKLEY (00:14:50):
 - 1. Building permit activity for April was tallied at \$\$397,319.20, including 1 new single family residence.
 - 2. The petitioners of the Carmela PUD requested a continuance.

3. A future land use amendment for the Darby Land Trust would be presented at the August meeting, pending receipt of documentation from Patel, Green & Associates.

B. PARKS AND RECREATION - COMMISSIONER BASSINGER (00:19:16):

 The Gardening 365 event scheduled for October was cancelled due to COVID-19 concerns.

- 2. The owner of The Blooming House Junk Shop requested to hold an event in the city park, which was denied due to restrictions on gatherings in open areas. The event was moved to the Heritage Bible Church.
 - a. Don Kandalec of Dunne Road expressed concern for the community's safety by the amount of attendees. Parking in the area would be limited, and permitting for the event was questioned.
 - i. Attorney Buhr discussed enforcement of state and county ordinances regarding masks and gatherings.
 - Pat Kandalec of Dunne Road asked why the event would be allowed in a residential area. Zoning allowances for the church property would be reviewed by city staff.

C. STREETS - COMMISSIONER SCHRADER (00:30:32):

- Commissioner Schrader and Bill Housel met with one of the residents to discuss the Pompanic Street drainage easement. D.C. Johnson would perform the survey work and draft the easement drawings needed for the bid packet.
- 2. A master drainage plan for the city was being prepared by Bill Housel to remedy areas experiencing drainage issues.
- 3. Staff contacted the contractors working on the county sewer line to have the damaged Curley Street sidewalks repaired and grass replaced.

D. WATERWORKS - COMMISSIONER STALLWORTH (00:32:24):

- 1. DEP approved the 2019 CCR. A 6.5% water loss was reported in the PSAR.
- 2. Daniel Magro of Aclus Engineering was researching a grant available from DEO to address some of the outdated components of the water system.
- 3. Commissioner Stallworth cautioned residents of mailings being sent out for water quality testing.

6. **CLERK'S REPORT (00:36:51):**

- A. Superior Siteworks was working to prepare drawings of the Curley Street water lines that need relocation.
- B. St. Anthony's Catholic School delayed opening by two weeks.
- C. Waste Connections did not complete their scheduled trash pick-up and would resume collection the following day.
- D. Commissioner Markley discussed annexation of the properties south of city limits connected to the water lines.
- E. Commissioner Bassinger recommended reviewing the contract with Waste Connections due to issues with their quality of service.
 - 1. Attorney Buhr recommended sending a notice of noncompliance, followed by a meeting with staff and a representative from the company.
 - 2. Pam Pepperman of Palm Street stated that the price for recycling provided in the bid documents was not made available.

7. **UNFINISHED BUSINESS (00:44:20):**

- A. Repairs to the Laurel Court drainage issue were previously delayed due to a lack of responses from multiple vendors. Commissioner Schrader recommended having Bill Housel review the issues.
 - Public Works Director Israel Huron discussed contacting a new vendor and the timeline for repair once parts were received. An agreement with the HOA was recommended before staff performed any work connecting to the nearby retention pond.

8. **NEW BUSINESS (00:53:05):**

A. Commissioners Bassinger, Schrader, and Vogel were sworn in by City Clerk Rick Alley. Mayor Anderson passed the gavel to Attorney Buhr for the organization meeting.
